Fee Schedule

Scale of minimum fees for incorporation and maintenance of exempted and ordinary non-resident Cayman Islands Companies.

A. INCORPORATION:

Preparing and filing Memorandum and Articles of Association (and, in the case of Exempted Companies, the requisite affidavit), preparing all corporate organisation documents, applying for and obtaining Tax Exemption Guarantee (Exempted Company) or obtaining Non-Resident Designation (Ordinary Non-Resident Company):-

B. CORPORATE MAINTENANCE BY SH CORPORATE SERVICES LTD. (either type of company):

- (i) Fee payable annually in advance for provision of registered office, keeping corporate records, preparing Minutes of Annual General and Statutory Meetings, filing Annual Returns to Government and advising of any changes in laws affecting the Company. **US\$1,200.00 p.a.**
- (ii) Fee payable where SH Corporate Services Ltd do not provide the registered office but are required to file the corporate documents with the Registrar. **US\$ 300.00 p.a.**
- (iii) Provision of representative person to a Cayman Registered Vessel owned by a Company. **US\$1,000.00 p.a.**

1. 4. Miscellaneous disbursements for incorporation of the Company of US\$2,390.00 will be added to the incorporation costs and will cover the costs of the Certified Copies of the Memorandum and Articles, the Tax Exemption Certificate, the fee for filing the Register of Directors/Officers, Stamp Duty on Articles, Printing and Local Couriers. If the Company is incorporated on an "Express Basis" a further disbursement of US\$487.80 will be added to the incorporation invoice.
